

PRIVACY POLICY

Beyond the Tee is committed to maintaining the privacy of your information. This notice explains how we collect, share, and protect the information that you provide to us. By accessing our website, you are consenting to the terms described below.

HOW WE COLLECT INFORMATION

In order to optimize your use of our website and services, we may need to collect the following types of information from you:

Contact, Registration, and Billing Information

You may choose to provide us with information about you or a camper in order to enroll in a camp. Specifically, this personally identifying information includes:

Contact information, such as your name, e-mail address, mailing address, and phone number;
Camper information, including a name, date of birth, and gender; and sizes for apparel
Billing information, such as a credit card number and a billing address.

HOW WE USE YOUR INFORMATION

We use your personal information to allow you to download camp brochures, request information from specific camps, receive e-mail updates containing news or camp schedules, create an account, and register and pay for a camp.

HOW WE SHARE YOUR INFORMATION

In general, the information we collect is protected against unauthorized access and is not sold to or shared with third parties. In the following circumstances, however, we may disclose the following:

Your name and email address to our affiliated golf courses.

Your email information may be used to communicate and market future offerings of our programs and programs through the individual courses.

Account or other information when we believe disclosure is necessary to limit our legal liability or to protect our rights or property;

Account or other information to a law enforcement agency or other third parties if it is necessary to comply with law;

Account or other information to protect the rights or property of third parties or the users of our website;

Account or other information to service providers engaged by us to execute certain activities including payment processing; and

Account or other information as part of a merger, sale, or other business transfer.

HOW WE PROTECT YOUR INFORMATION

Our website has security measures in place to protect your information and to maintain data accuracy. The confidential data you submit is encrypted using industry-standard Secure Socket Layer ("SSL") encryption, utilized by most popular browsers.

PRIVACY POLICY CHANGES

We reserve the right to amend this Privacy Policy at any time. Your use of our website after changes to this Privacy Policy are posted constitutes your acceptance of those changes.

WEATHER POLICY

In the instance of inclement weather, we will make every effort to determine whether or not to cancel class in advance, so please check your email. In most cases, drizzle or light rain does not constitute a case for cancellation. Students should pack rain gear in their bags for each session. Any sessions cancelled due to inclement weather or otherwise by a Beyond The Tee Training Administrator will result in one of the following changes to the camp/academy schedule:

Campers will be given the option to make up the session by attending another date during one of our other sessions at the same facility or additional time may be added to remaining dates of the camp/academy or an additional day may be added to the camp/academy, as specified by Beyond The Tee Training Administrators.

REFUND POLICY

If cancellation is necessary, any camp or clinic can be refunded in full (minus \$5 administration fee) if canceled with a Beyond the Tee administrator at least one week (seven [7] days) before the advertised first day of the camp or clinic, of which the student was originally registered.

Any cancellation inside of seven (7) days from the advertised first day of the camp or clinic will result in providing the student with a voucher in the amount of the price of the camp, which can then be used toward the registration fees of the next camp or clinic of their choosing.

This voucher will be good for up to one (1) year from the date of issue, and if it is not used, the amount of the voucher is considered to be forfeited by the owner.

If a student does not attend a camp or clinic that they were registered for, and did not cancel with Beyond the Tee administrators before the camp start date, no refund will be given.
